Canton, Dedham, Dover, Dover-Sherborn, Framingham, Holliston, Hopkinton, Medfield, Millis, Natick, Needham, Norwood, Sherborn, Walpole, Wayland, and Westwood.

Our Programs and Services

TEC provides a continuum of outstanding public special education day programs for students ages 3-21. Each of TEC's programs provide a highly supportive, engaging and personalized environment specifically designed to meet each student's individual learning, physical, social-emotional and health care needs. We offer families a range of educational choices taught by caring, experienced and certified Massachusetts teachers, therapists and specialists. Our primary goal is to promote student growth and independence in order to reintegrate students into their home school and community whenever possible.

TEC also provides a range of services for our districts including:

- Educator professional development and job-alike networking groups
- TEC Online Academy providing supplemental online courses to high school students
- The sponsoring organization of TECCA, the Commonwealth Virtual School
- Student Internship and Career Exploration Program and College Fairs
- A statewide cooperative purchasing program supporting over 100 school districts
- TEC Student Data Privacy Alliance—protecting students in MA, NH and RI

Letter from The Executive Director



Dear TEC Community Members,

It is my pleasure to present TEC's 2019-2020 Annual Report to you. In this report you will find detailed cost saving information about TEC's student programs and an overview of the professional services we provide to our regional learning community. This year it also includes the story of how our staff, students, and families coped with the unique and disruptive COVID-19 health crisis that impacted our world.

The pandemic emerged as a health emergency in early March and lingered longer than anyone anticipated. As schools across the state were mandated to close, instruction abruptly shifted from in-person to remote. TEC, like our member dis-

tricts, was forced to adapt instruction and therapies for our diverse learners to a fully online format with little time for planning or preparation. As the initial weeklong quarantine stretched into months, our talented leadership team and staff provided exceptional support to our students, their families and districts. Every member of TEC's staff contributed, adapting with relentless determination and courage to every new challenge. They were amazing!

While this health crisis reduced the demand for some of TEC's traditional services, it increased it for others. For instance, the unexpected shift to a remote learning environment decreased enrollment in our professional development offerings, while at the same time many new districts enrolled in the TEC Student Data Privacy Alliance. Our Fuse Fellowship Program had to end the once thriving cross-district personalized coaching experience between teachers to focus on strengthening remote learning experiences within each participant's own classroom and district. TEC promoted inter-district collaboration via Zoom, and we supported one another through countless distressing days by sharing innovative ideas and successful strategies, as we faced the myriad of challenges related to the pandemic *together*.

Despite the relentless challenges of 2020, it will be remembered as a busy and successful year of *learning* as we were all forced to rethink our fundamental models of teaching, learning, communicating, and networking. From the classroom to the conference room, our circumstances revealed that there were new flexible and effective ways available to meet the needs of our students, families, staff and districts.

In the words of Helen Keller, "a bend in the road is not the end of the road unless you fail to make the turn." The year of 2020 will long be remembered for the many unforeseen twists and turns that we navigated *to-gether* and *created more possibilities for success*.

We are so grateful to the many people whose support and encouragement helped us through this unique school year especially the TEC Board of Directors, the TEC Staff, our district and school leaders, and all of our educators, school committee members, students and families across our resilient collaborative community. TEC Progress Toward Reaching Our Goals

The Education Cooperative actively develops and coordinates educational and organizational programs to meet the needs of our member communities and their students. Below is an overview of the objectives established in the TEC Collaborative Agreement that were accomplished during the 2019–2020 school year. These objectives are embedded in the TEC Annual Strategic Plan and progress is monitored throughout the year through updates provided by TEC Administrators at Board of Directors meeting.

1. Student Achievement Goal: To enhance and expand learning opportunities to meet the diverse needs of all students:

- TEC High School partnered with Best Buddies for job and interview training and offered their Self-Advocacy Program to the High School Students.
- A Floyd Family Foundation grant enabled TEC High School to offer a new blended Humanities Class combining History and English. Students were offered curriculum choices and encouraged to take charge of their own learning.
- TEC Phoenix Academy students attended a series of outings at Hale Reservation's challenging ropes courses and other outdoor activities designed to promote the development of self confidence, life and communication skills.
- TEC High School and TEC Phoenix Academy formed collaborative teams to analyze student data create and created a personalized learning plan for each student.
- TEC Phoenix Academy provided weekly trips Unity Farm Animal Sanctuary. The students perform chores for the resident animals to develop new life skills and increased self-confidence.
- Transition I and II students continued to access community-based job sites utilizing TEC vans, as well as ride shares services and public transportation to promote increased independence.
- Transition II Students opened a TEC Café on the lower level of the Mansion Drive facility, offering fresh baked goods and coffee. The students were able to learn and apply vocational and communication skills.
- TEC Campus School adopted the ACE[®] ABA Software System for learners with autism, designed to assess, teach and evaluate progress using evidence based procedures.
- Successfully placed a Transition II student at Mass Bay Community College with the assistance of an on-campus disability coordinator, creating a model for expansion of this program.
- Promoted the ubiquitous use of assistive technology tools by providing access to in-classroom coaching from an Assistive Technology Specialist and an Augmentative Alternative Communications Specialist.
- Coordinated two regional college fairs attend by over 115 colleges, universities and gap-year programs.
- Provided high school juniors and seniors with internship opportunities with over 150 sponsor organizations. Piloted career internship experiences for students with special needs.
- 2. Professional Development Goal: To create innovative learning opportunities and address, identify, and maintain operational and educational needs.
 - Cohort 2 of the TEC-Highlander Fuse MA Fellowship 18 month professional development program was launched. Focused on shifting from traditional instruction toward personalized learning, and financially sponsored by TEC, this cohort of highly skilled teachers represents a regional professional learning network spanning 10 member districts with 22 new Fuse Fellows.
 - Coordinated a series of regional SEI endorsement courses for teachers and administrators.
 - Expanded the TEC Student Data Privacy Alliance. Free to TEC member districts, this program has expanded to support school districts in Massachusetts, New Hampshire and Rhode Island understand and address student data privacy issues. Districts now have access to over 5000+ signed agreements, accelerating the protection of student data.
 - TEC Staff presented at the following conferences: MASS CUE, Council for Exceptional Children (CEC), METAA Conference, MASC-MASS Joint Conference, COSN, & Access4Learning, and MASS MASC Spring Leadership Conference.
 - Facilitated monthly job alike meetings: Superintendents, Assistant Superintendents, SpEd Directors, Technology Directors, Technology Integration Specialists and Guidance Directors.

- 2. Professional Development Goal Continued: To create innovative learning opportunities and address, identify, and maintain operational and educational needs continued:
 - TEC Campus School collaborated with Dr. Alice McIntyre to create a mindfulness program for the teaching staff and students.
 - Coordinated a panel discussion of TEC district leaders to present at MASS Summer Leadership Conference focused on developing district Safety Assessment Teams and implementing a formal framework of student threat assessment and intervention.

3. Operations Goal: To improve our ability to provide proactive support to TEC programs.

- Bi-monthly staff meetings and budget meetings have been implemented to enable more effective communications.
- Eagle Scout Christopher Giovanni, constructed beautiful new accessible plant stands in the TEC Sensory Garden.
- All Hazards Emergency Plan including communication protocols, provided expert training and simulations of emergency situations such as an active shooter or hostile intruder.
- Coordinated a regional Legislative Breakfast hosted by the Dedham Public Schools.
- Provided ongoing support to TECCA including payroll processing and guidance on internal operations.
- Redesigned and relaunched the TEC website through an organizational-wide strategic planning process designed to review and revise the content published by each school program and service.
- Designed an improved custom interface for processing TEC bids.
- Provided Zoom access to all TEC staff members, allowing remote interaction for instruction, professional development, administration, Board meetings and finance and operations.
- Initiated a comprehensive Strategic Planning process that included over 30 staff members to coordinate TEC's response to COVID-19 in academics, facility reopening, social emotional needs, and operations.









FY 2020 Student Enrollments by Program

TEC provides member and non-member school districts with an array of specialized services designed to address the needs of

students with moderate to intensive disabilities ages 3-21. The Education Cooperative (TEC) provides an engaging and supportive learning environment for students with complex learning needs. Our talented, experienced and caring educators work as an integrated team to empower students to embrace their dreams and goals, take control of their lives, and be actively involved in their own learning process in order to reach their full potential.

The licensed, skilled and experienced staff at TEC utilize an integrated team approach to provide comprehensive instruction and promote independence based on the unique needs of the student. Students join a cohort of similar peers based on their level of academic, functional and social skills. TEC's dedicated and expert educational and therapeutic staff members seamlessly collaborate to ensure consistency of instruction is embedded throughout each student's day across all settings to maximize student potential and promote growth and independence.

TEC works in partnership with each student's home district to create a purposeful and engaging educational plan based on the student's personal learning, health, and behavioral needs. This includes access to differentiated instruction provided by skillful, experienced educators and therapists and natural movement across TEC programs based on the emerging needs and interests of the student.

All TEC services are designed to provide meaningful and authentic inclusion opportunities in the least restrictive engaging educational environment. TEC offers services at Westwood High School as well as at our beautiful campus located in East Walpole. The East Walpole campus houses the TEC Campus School as Public Day Special Education School Program fully approved by DESE. TEC Intensive Programs (

School, a Public Day Special Education School Program fully approved by DESE, TEC Intensive Programs (Pre-K – age 21) and TEC Alternative High School (Grades 8-12).

Every TEC classroom offers learners access to highly qualified, DESE licensed, caring teachers, therapists and health care professionals who work as a collaborative learning team focused on the success of each student and supported by the latest educational resources, strategies and assistive technologies.

TEC Campus School Intensive Continuum Ages 3-21

TEC Campus school provides multisensory instruction in a supportive setting to meet the individual learning, communication, motor, behavioral, daily living, health care, and transition needs of students ages 3-21.

The Early Childhood and Elementary Programs are designed for students age 3 through age 10 at the beautiful TEC Campus School in E. Walpole, offering students a warm and engaging learning environment specifically designed to support their social, learning and medical needs.

All classrooms are staffed throughout the day with DESE licensed teachers, Registered Nurses and Therapists who seamlessly integrate their instruction into daily classroom experiences. Assistive Technology, as well as Augmentative and Alternative Communication are authentically integrated of each child's educational experience.

Typical disabilities served in this program are:

- Multiple Disabilities
- Cerebral Palsy
- Developmental Delays
- Neurological ImpairmentSensory Impairment
- Medical Fragility

Program Highlights:

TEC Campus School Intensive Continuum Ages 3-21

Moderate Continuum of Programs

Elementary, Middle, & High School (also see Transition Services) Satellite program: Westwood High School

These programs focus on explicit instruction in academic and social skills across multiple settings, including an emphasis on community instruction.

Typical disabilities of students in the Moderate Continuum include:

- Autism
 Developmental Delays
 Intellectual Disabilities
- Communication Disabilities

The academic curriculum is aligned with the state curriculum frameworks and modified to meet the individual student's needs. Students often work on skills with the support of therapists as well as behavioral strategies to increase their independence across environments. Functional life skills are fully embedded into the curriculum as well.

Our program includes:

- Increased functional and age-appropriate academic skills
- Engagement in meaningful, individualized instruction aligned to MA Curriculum Frameworks
- Focus on Communication and Social Skills supported by assistive technologies
- Motor Skills Development with access to in-house therapeutic pool, accessible playground, fitness center
- Life skills and personal management including simple meal preparation, self-care, selfadvocacy skills

Satellite program: Westwood High School

The satellite program is embedded at Westwood High School, providing students with a typical high school experience while concentrating on developing needed skills for independent living. Students aged 14-18 strengthen their social skills and behaviors appropriate for the workplace and are provided with daily opportunities to practice and apply new skills in authentic situations. Academic instruction is focused on functional vocabulary, writing and math skills for daily living, and classroom activities concentrate on living skills such as cooking and independent self-care. Students are provided supervised internships in pre-vocational settings to apply and practice their skills and appropriate behaviors in a workplace setting.

Academic Behavioral Learning Environment (ABLE)

The TEC ABLE Class provides multisensory instruction utilizing the principles of ABA to develop communication and functional skills in a supportive setting meeting the individual learning, physical, behavioral, and health care needs of each student. TEC's ABLE Class incorporates a flexible program structure based on individual student needs and skills. The principles of ABA are applied throughout each student's school day. Individualized behavioral support plans are also an essential part of students' daily lives. Licensed special education teacher, in-class BCBA support, Registered Behavior Technician and Safety Care Trained Staff are in classroom.


TEC Campus School Transition Services

Our Transition Services provide real-world learning opportunities and individualized support to help students shape their lives, understand their unique capabilities, and take an active role in preparing to accept the responsibilities of being an adult. Our talented, experienced and caring educators work as an integrated team with the family and student to define and embrace their dreams and goals, take control of their lives and be actively involved in their own learning process to reach their full potential.

This program focuses on students ages 18-21 (flexible based on student needs) and includes a functional skills curriculum and vocational/transition skills for students age 18 to age 21. Our classrooms emphasize an Integrated Related Service Approach to maximize student learning involving a cross section of people, places, and situations. Students are encouraged to assume emergent adult roles in their communities through: life skills, employment, independent living, social skills and technology application.

TEC Phoenix Academy's main goal is to prepare our students in Grades 7-12 for postsecondary education and training in an atmosphere of high expectations, strong support and personal responsibility. Designed for students who have found it difficult to cope with the large high school academic and social demands, TEC Phoenix Academy (TPA) provides support for students who prior to enrolling have experienced behavioral challenges that are not limited too:

• Anxiety

• Depression

• ADHD

- Mood Disorders
- Oppositional Defiance Disorder

TPA engages students and supports their development of adaptive and academic skills that will allow them to return to their local high school.

We have small classroom sizes and individualized plans for each student that goes beyond the IEP. We offer vocational training in culinary arts as well as various community involvement opportunities; our "whole person" approach provides the necessary educational, emotional, social connectedness and therapeutic learning environment where students can thrive.

TPA students have access to hands-on learning experiences and vocational opportunities including Service Learning Projects, Culinary Arts, Car Detailing, Graphic Design Programs, Computer Repair, Digital Audio Music Production and Woodworking as a part of the elective offerings. Students are also exposed to a variety of physically engaging activities such as skiing and snowboarding at Wachusett Mountain, hiking and biking. Students focus on developing good health habits at LA Fitness and participate in groups that focus on DBT Skills (Dialectical Behavior Therapy), Smoking Cessation, Social Pragmatics and Transition Skill Development.

TPA Students pursue a wide range of career exposure including two and four year colleges/universities, post-secondary training programs and employment. Field trips are offered regularly to provide both community service opportunities and exploration of college and career options for students upon graduation.

TEC High School is a student-centered, alternative therapeutic school which offers a caring and supportive academic experience to adolescents in grades 8-12. At TEC, experienced, DESE licensed classroom teachers and special educators help students master a rigorous college preparatory curriculum while our full-time licensed clinical staff assists students in reaching their social emotional development goals.

Designed for students who benefit from a nontraditional high school experience due to social-emotional challenges such as anxiety, depression, school phobia and other related mental health disorders, TEC High School students experience an engaging, challenging and diverse academic curriculum within a small, personalized and connected learning community. Along with core classes and electives, TEC students receive academic mentoring from subject teachers in a daily academic advisory period. College bound students are supported throughout the college admissions process in partnership with their sending district. Our dedicated and caring team is committed to using data-driven pedagogical and therapeutic best practices as they help each student reach his or her fullest potential.

TEC High School students experience the daily integration of technology with a 1:1 Chromebook program, daily Mindfulness practice, Blended Learning, weekly Dialectal Behavior Therapy (DBT) group sessions and yoga class, honors classes across the curriculum, art therapy, diverse electives in the arts and sciences, community service and school leadership opportunities, and frequent off-campus field trips ensuring engagement with the world beyond the classroom.

At TEC High School, counselors are available to students throughout the school day for individual sessions as well as group work on topics such as social skills and DBT.

Curran Early Childhood Education Center in Dedham on February 7, 2020. TEC was delighted to host Senator Jason M. Lewis, Senator Becca Rausch, Representative Paul Tucker, Representative Paul McMurtry, and Representative David Linsky. Our honored guests were treated to a delicious buffet breakfast provided by the Dedham food service staff and heard updates from our elected officials on the pressing changes in education financing. Thank you to everyone who participated in making this such an informative event especially our esteemed guests.



TEC Professional Development

The Education Cooperative provides high quality Professional Development to support districts, schools, individual educators and support staff to improve their professional practice and enable student success by offering a variety of opportunities: facilitate synchronous and asynchronous online courses, face-to-face and hybrid courses that cover a breadth of topics and content areas as are appropriate for all types of educators, administrators, and support personnel. Many of these courses offer graduate credit as well as Professional Development Points (PDPs) for licensure renewal. Examples includes:

- SEI Teacher endorsement courses that fulfill DESE Licensure requirements.
- Self-paced online courses, several of which can be used to meet state requirements for license renewal; participants can earn Professional Development Points upon successful completion. Our self-paced online courses include:
 - Strategies to Enhance Instruction of ELLs in the Classroom (15 PDPs)
 - Engaging All Learners with Differentiated Instruction (15 PDPs)
 - Connecting Behavioral Health & Social Emotional Learning to Success in School (15 PDPs & 1 graduate credit)
 - Introduction to Coaching in Schools: Supporting Professional Development and Growth through Coaching (15 PDPs)
- Workshops that address discrete/current issues in education.
- School-based and district-wide initiatives developed to address specific areas of interest for a school/district.
- Cross-district initiatives that bring multiple districts together to address issues shared by TEC participating districts, collaborating to further each district's approach to the issue. This professional development typically can be designed as a multi-session offering throughout the course of a year.

TEC's online courses have generated continued interest in TEC member districts. Other districts have purchased district licenses in order to secure annual access for these exceptional courses. These courses have been reviewed and updated to include current resources, ensuring viability and application for the future. TEC has also recently updated its Moodle platform to provide expanded access to all course elements.

The offerings described above are available throughout TEC's member districts and to other districts across the state.

During fiscal year 2020, Janet Buerklin, Ed.D, TEC's Professional Development Coordinator, developed multiple graduate level courses in partnership with area educators, colleges and universities. The courses addressed all areas of the MA PreK-12 curriculum frameworks and were designed to provide educators with high quality, cost effective access to the professional development required for Massachusetts licensure.

Sheltered English Instruction

To enable educators to meet DESE's mandatory SEI endorsement requirement, TEC offered multiple 45 hour teacher endorsement courses. These courses focus on strategies to support English Learners, enabling them to access content instruction through evidence based reading, writing, and vocabulary interventions. The SEI courses were offered in person during Fall 2019 at Dedham Middle School and Boston Bridge Charter School, and in Spring 2020 at Natick High School, which transitioned to synchronous online instruction in March 2020 due to Covid-19.

Varied Professional Development Offerings:

During the **Summer of 2019,** TEC offered over twenty-five workshops for all Pre-K-12 educators and administrators that included curriculum content, special education instruction strategies and literacy support programs, and differentiated instructional pedagogy to enable all learners to succeed. Examples of the diverse workshops include: Preparing for the SEI MTEL, Better Behavior Toolbox, History/Social Science standards, storytelling, writer's workshop, website design, and "Assistive Technology and Universal Design for Learning" in collaboration with DESE.

Fall 2019 offerings included such courses and workshops as continuing "Assistive Technology/Universal Design for Learning" (AT/UDL), Social Emotional Learning, Mindful Approach to Teaching, Google Data Studies, and Safe Supportive Learning Communities to name just a few.

TEC Online Learning

TEC is a regional leader in online learning and the proud sponsor of TECCA, the TEC Connections Academy Commonwealth Virtual School established in 2014. Although the governance of TECCA is independent from TEC, in compliance with regulatory requirements, TEC and our member districts continue to learn from the experience of sup-



porting the successful growth of this innovative alternative school that is benefitting students and families across Massachusetts.

TECCA: TEC Connections Academy

The mission of TECCA is to offer a rigorous, effective curriculum aligned to the Massachusetts Curriculum Frameworks and utilize unique technology tools to help every student succeed, while also encouraging social growth. After rigorous and extensive monitoring and review by the Department of Elementary and Secondary Education, the Board of Education renewed TECCA's Commonwealth Virtual School Certificate for 5 additional years, July 1, 2017 through June 30, 2022.

Full time enrollment in TECCA continues to grow reaching over 2,500 students and includes 368 individual online courses taken by TEC member district students, the balance being offered by Pearson Online and Blended Learing (POBL).

Online Learning Options for TEC-Member District Students

As a TEC-member-district benefit for sponsoring TECCA, free course seats were allotted to each district based on the current full-time enrollment at TECCA. There was continued strong participation in online course enrollments (1059 total) from TEC member district students in the fall semester 2019 and spring semester 2020.

The department of Professional Development, worked closely with TEC-member district guidance departments in this initiative and facilitated the student enrollment process between POBL and our member district guidance departments using a new Google-based enrollment process that not only saves districts valuable time but also minimizes the space for error.



Online Course Enrollments

Each year TEC member districts, through TEC's sponsorship of TECCA, have the benefit of receiving a number of free online courses. In FY2015 TEC member districts enrolled in 798 online courses and five years later, in FY2020, TEC member districts enrolled in a total of



1,121 online courses. The charts below show the significant growth in the enrollment in online courses by our member districts over the last 5 years.

In FY2020 TEC member districts enrolled in a total of 1,121 online courses. Of those online enrollments 517 were free at a cost savings of \$155,100 to TEC's member districts.

TEC Student Data Privacy Alliance

TEC Student Data Privacy Alliance

The **TEC Student Data Privacy Alliance** (SDPA) continues to lead the way in student data privacy. Working together, the TEC member Technology Directors leveraged their time, talent and negotiating strength to save hours of labor and thousands of dollars in legal fees for their districts. Most importantly, they have leveraged the collective influence of our regional group to influence vendors to protect all student data.

Initially launched in 2016 in cooperation with the SDP Consortium, TEC developed a statewide Student Data Privacy Agreement (DPA) for MA which articulated the vendor duties and responsibilities required to protect student data in compliance with all applicable federal and state privacy statutes. TEC's Student Data Privacy Agreements are legally enforceable documents and vendors agree to compliance with all applicable state privacy statutes, including the FERPA, PPRA, COP-PA, IDEA, 603 C.M.R. 23.00, 603 CMR 28.00, and state specific laws. In 2019 TEC expanded, adding statewide agreements for NH and RI.

TEC's annual service offers districts access to expert legal counsel and an experienced contract administrator who initiates the vendor agreements on their behalf. The alliance has grown to be a national leader in data privacy and now supports over 200 school districts in 3 states with over 5,000 signed, enforceable DPAs and protects over 530,000 students!

Fuse MA Fellows

The Fuse MA program, a partnership between TEC and

Highlander Institute, strives to share, implement, evaluate and scale best personalized learning practices by convening educators who are passionate about this work and committed to breaking down silos. The name FUSE captures how the experience both "ignites" a movement within schools and districts, and intentionally brings together like-minded educators to collaborate and grow.

Cohort 1 Fuse Fellows completed their 18-month program in June of 2019, a number of alumni expanded their role and leadership responsibilities:

TEC Student Career Exploration & Internships

The Education Cooperative's Internship Program is a selective, personalized career exploration placement program. Through the years we have developed outstanding relationships with highly sought after businesses, organizations and public sector employers.

The TEC Career Exploration & Internship Program offers students the opportunity to explore a variety of career paths by learning about their interests, strengths, and skills. Students intern at local businesses where they are mentored by a professional and experience the real world of work, gain employability skills, and are able to make well-informed career choices in the future. The internship program supports students' career exploration and college readiness by allowing students to hone in on their interests before entering college.

The internship program benefits districts by offering opportunities to their students that may not be available within their community. Our program is designed primarily for high school junior and senior students and works closely with over 150 sponsor organizations where they are placed under the supervision of dedicated career mentors.

During their internship, students receive one-on-one career counseling from an Internship Coordinator and learn new skills including: resume development and writing, interviewing, career exploration and self reflection, professional networking, and attend college admission and essay writing workshops.

Guidance Counselors from all TEC districts participate in this successful monthly job alike group and share best practices and resources such as curriculum, testing, college admissions, etc. During the 2019-2020 academic year, this job alike discussed relevant timely topics including admission letter writing, hospital re-entry and supporting students returning from extended absence.



Cooperative Purchasing

For over 30 years TEC has been offering competitively bid savings opportunities on thousands of products through our locally-managed Cooperative Purchasing Program. We work on behalf of the school systems to secure volume purchasing contracts that have benefits that are measurable and cost effective. In fiscal year 2020 TEC continued its commitment to improve efficiencies and increase cost savings through the facilitation of TEC Bids. By utilizing collective volume purchasing, participating school departments are able to obtain the best possible pricing from vendors while taking advantage of a streamlined bid process. TEC bids, a free member benefit, continues to evolve to better reflect the needs of all participating school departments throughout Massachusetts.

Association of Educational Purchasing Agencies (AEPA)

TEC participates in a national non-profit organization, the Association of Educational Purchasing Agencies (AEPA), a cooperative purchasing group consisting of 29 state agencies. TEC's involvement with the group began in 2010 when Massachusetts allowed interstate cooperative purchases. By partnering with AEPA, TEC is able to offer volume discount purchases to school districts in the Commonwealth. The AEPA contracts offer savings through bids in such categories as office and classroom furniture, interactive classrooms, industrial arts, technology, printers and digital copiers and many

Cost Effectiveness of Programs

This section offers quantitative and qualitative data to help readers understand the cost-effectiveness of utilizing the Special Education, Cooperative Purchasing and Professional Development and Online Learning programs offered at TEC.

Special Education focuses on the comparable costs incurred by School Districts' placement of students at TEC programs compared to those at comparable private schools that offer substantially similar programs. Comparisons are made with the two different Network Continuums offered at TEC: Moderate and Intensive, and also with our two alternative schools: Phoenix Academy and TEC High School.

Our **Cooperative Purchasing** program will evaluate the savings realized from increased bargaining power associated with pooled purchases in the different bid categories offered at TEC. The evaluation focuses on costs savings realized by choosing to utilize our Cooperative Purchasing services and buying from one of TEC's six bids.



Cost Effectiveness Special Education Services


Special Education: Intensive Continuum

The Intensive Continuum provides high quality, cost-effective educational programs that maximize the growth and development of children, adolescents, and young adults diagnosed with intensive special needs through highly specialized and eclectic teaching methodologies within substantially separate classrooms of public school environments. The Intensive Continuum at TEC has an annualized in-district tuition rate of \$60,588 or \$336.60 per day. This rate is 28% lower than the median and 32% lower than the average rate of similar private school programs.



Special Education: Moderate Continuum


The Moderate Continuum provides high quality, cost-effective educational programs that maximize the academic and life skill development of children, adolescents, and young adults diagnosed with mild to moderate disabilities through highly specialized and eclectic teaching methodologies within substantially separate classrooms of public school environments. The Moderate Continuum at TEC has an annualized in-district tuition rate of \$50,764 or \$282.02 per day. This rate is 41% lower than the median and 40% lower than the average rate of similar private school programs.



Cost Effectiveness Special Education Services


TEC High School

TEC High School is located at the TEC Campus in Walpole, MA. The goal of the school is to enable students to overcome those academic, social, emotional, and personal issues which have been a source of interference in their past school experiences and to begin to establish positive habits of academic study and improved self-esteem which can result in a substantial pattern of successful functioning for each student. The school functions in a cost-effective manner to provide services to students throughout the metro-west area of the state. The annualized tuition rate at TEC HS is \$39,323 or \$218.46 per day for in-district placements. This rate is 35% lower than the median and 37% lower than the average rate of similar area private schools.



TEC Phoenix Academy (TPA)

Phoenix Academy provides a safe, supportive, and structured environment in which students with complex emotional, behavioral and academic issues are assisted in improving their basic skills, earning credits toward a high school diploma, and developing strategies to improve their ability to function successfully in their communities. The in-district annualized tuition rate is \$47,928 or \$266.27 per day. This rate is 25% lower than the median and 26% lower than the average rate of similar private school programs.



Cost Effectiveness Cooperative Purchasing

TEC facilitates Cooperative Purchasing bids that offer significant savings to participating School Districts as a result of volume purchasing. The benefits that TEC provides are measurable and cost-effective. The following is a list of bid offerings for larger quantities items that were awarded by TEC in FY2019 with an estimated annual savings based on Massachusetts state contracts and Market Price. A sample of bid items is also included that lists specific items from TEC bids compared to state and online discount pricing and the unit savings.

Cost Effectiveness Professional Development

TEC continuously works to negotiate with entities with which we form partnerships to present our professional development offerings at the most affordable rates for teachers. Additionally, we seek out grant opportunities that enable us to have the costs defrayed or underwritten, further reducing the direct cost that teachers and/or districts have to pay to secure high quality, current, and relevant professional development.

In FY2020, TEC designed and offered 53 professional development workshops including our online learning courses. A large emphasis was placed on SEI teacher and Administrator endorsement courses. In systems that hosted a course, district participants took the course at a reduced rate of \$375 vs. the full rate of \$450. We thank our members Dedham, Natick, and Westwood, for hosting courses for TEC.

We also shared courses with sister collaborative EDCO, and more teachers were able to take selected EDCO courses for the reduced rate offered to EDCO districts rather than the cost to at-large districts.
